Pursuant to Utah Code Ann. § 63G-4-207, Utah Code Ann. § 63G-4-502, Rule R746-100-7 Intervener and Petitioner Mrs. Corinne Nielson Roring ("Intervener"), respectfully requests for leave to give notice of intent to file an emergency petition to intervene in this docket and object to the Public Service Commission of the State of Utah ("Commission")'s Approval of the Power Purchase Agreement ("PPA") between Pacificorp and Blue Mountain Power Partners, LLC.

In support of this Notice of Intent to file Emergency Petition, Intervener states as follows:

1. Intervener is the Trustee for land located in South Utah, San Juan County to be identified in the Emergency Petition.

They have alleged some concerns they want to raise. They haven't alleged an issue any legal right or interest that will be substantially affected, like is required as is required under the statue."1
- 3. Intervener believes Title 63G, Chapter 4, Section 207, c was not completely satisfied beyond question until the Testimony of Mr. Michael Cutbirth, in the Hearing before the Commission on September 19, 2013.
- 4. As a result of Mr. Cutbirth's Testimony, requests have been filed in accordance with the Freedom of Information Act and the laws relating to Grama Request for Records in the State of Utah for crucial documentation necessary to support and prove the elements in the Emergency Petition Intervener intends to file. This information, and the September 19, 2013 testimony of Mr. Cutbirth are significant components of Intervener's Emergency Petition. Receipt of this information by Intervener has likely been affected by the present Government Shutdown.
- 5. Intervener is seeking to secure the necessary documentation by other means that may be available.
- 6. Intervener has a direct interest in these proceedings and the outcome may have a substantial effect upon Intervener.
- 7. Intervener seeks to protect her interests, pursuant to Title 63G, Chapter 4, Section 207, c and other applicable Utah State Law and Regulations.
