***MOTION TO CONTINUE STATUS
CONFERENCE***

Intervenor Ellis-Hall Consultants, LLC (“Ellis-Hall”), by and through counsel of record, moves the Public Service Commission for a continuance of the July 29, 2013 status conference in the above-referenced matter. The basis for this request is as follows:

On July 15, 2013, notice was given of a July 23, 2013 status conference in this matter. Notice, however, was not given to Ellis-Hall. By chance, on July 19, 2013, Ellis-Hall discovered that a status conference had been scheduled in this matter and promptly entered an appearance. Ellis-Hall appeared at the July 23, 2013 status conference without counsel to inform the Public Service Commission of a conflict of interest between counsel for Latigo Wind Park, LLC and Ellis-Hall. At the hearing, the presiding officer instructed Ellis-Hall that they would have to appear with counsel on July 29, 2013 at 8:30 a.m.

Ellis-Hall retained the law firm of Wood Balmforth LLC to represent them in this matter. Ellis Hall's counsel respectfully requests that the Public Service Commission continue the scheduled status conference because Ellis-Hall's counsel is unavailable on July 29, 2013 at 8:30 a.m. because of a previously scheduled pretrial conference in Utah Third District Court. Ellis-Hall respectfully requests a short continuance to permit counsel to attend and to also review the status of the pending matter in order to be able to know what scheduling dates will be reasonable given the issues presented. Ellis-Hall's counsel is available on August 2, 5, or 6, 2013, or on another date that is mutually agreeable to all parties.
