Pursuant to Utah Administrative Code § R746-100-11.F, Latigo Wind Park, LLC (“Latigo”) submits its Response to the Petition for Review and Rehearing of Corrine Roring, filed on November 4, 2013 (“Petition”).<sup>1</sup> The Petition does not comply in any regard with the requirements of Utah Code Ann. § 63G-4-301(1)(b)(ii): “The request [for rehearing] shall . . . state the grounds for review and the relief requested.” Mrs. Roring’s one-page document makes no attempt to comply with this requirement, and there is no legal mechanism that would allow her to supplement the document at a later time.
