By The Commission:

On October 11, 2013, the Office of Consumer Services ("Office") filed a petition for review and clarification ("Petition") of the Commission's Order issued in this docket on September 13, 2013 ("Order"). Specifically, the Office requested the Commission revise the Order to remove any reference to the reasonableness of the continuation of the Cool Keeper program, including but not limited to the Commission's finding that the continuation of the Cool Keeper program is reasonable, in the public interest, and will provide for a cost-effective resource for customers.<sup>1</sup> No party filed a response to the Petition.

The Commission's finding from the Order cited above was based on the Company's testimony in this case and our prior decisions approving or modifying the Cool Keeper program, which no party here asked the Commission to reconsider. Therefore, consistent with Utah Code Ann. §§54-3-1, 54-4-4, and with the Commission's decisions in Docket Nos. 02-035-T12, 09-035-T08, and 09-035-27, the Petition is denied.

Review of this order is governed by Utah Admin. Code § R746-100-11, Utah Code Ann. §§ 54-7-15, 63G-4-302(b) and 63G-4-401(3), which requires the filing of a petition for judicial review of an order constituting final agency action within 30 days of issuance.
