In support of this petition, UCARE states as follows:

1. On January 3, 2014 Applicant filed an application for a rate increase, including proposed changes to rate design and fixed charges.

2. As current or potential net-metering residential customers of Rocky Mountain Power, UCARE's legal rights and interests may be substantially affected by this proceeding, which will determine Applicant's rates, rate structures, and the incentives created thereby.
3. UCARE has not fully determined specific positions they will take or the relief they will seek. UCARE seeks to intervene for purposes of protecting its interests as they arise.
4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing UCARE to intervene.
5. UCARE's interests are not adequately represented by another party in this proceeding.
