## ISSUED: June 19, 2014

On January 22, 2014, the Commission issued a scheduling order, notice of scheduling order suspension and notice of hearings ("Scheduling Order") in these dockets. On June 16, 2014, the Commission issued a first order modifying scheduling order directing parties to provide PacifiCorp with statements of issues and positions and PacifiCorp to compile those statements into a joint position matrix to be filed with the Commission in advance of the hearing in these dockets scheduled to begin July 28, 2014 ("First Order Modifying Scheduling Order").

On June 18, 2014, the Division of Public Utilities ("Division") filed a motion to amend schedule and request for stipulation hearing ("Motion") in Docket No. 13-035-184. The Motion states the Division's belief that a negotiated settlement is imminent and requests the Commission amend the schedule in these dockets as follows:

> I. The remaining Phase I and Phase II dates for testimony and hearings in Docket No. 13-035-184 will be suspended with the exception of net metering. Net metering testimony and hearing will continue as scheduled.

- II. The schedule for Docket No. 13-035-196 which is running concurrently with Docket No. 13-035-184 will remain unchanged.
- III. The public witness hearing will remain as scheduled on July 29, 2014.
- IV. The Hearing dates for Phase II on Monday, July 28, 2014, through Friday, August 1, 2014 will remain as scheduled.

The Division further requests the Commission set a hearing for an executed stipulation on June 30, 2014.

The Division represents a draft of the Motion was circulated to the parties in these dockets and is authorized to represent that the Office of Consumer Services, Utah Association of Energy Users, Federal Executive Agencies, Kroger Co., Wal-Mart Stores, Inc. and Sam's West, Inc., Nucor Steel-Utah, and the Sierra Club support the Motion. The Division represents that Utah Industrial Energy Consumers, UCARE, The Alliance for Solar Choice, IBEW and Utah Clean Energy do not object to the Motion. Finally, the Division represents it has not received notice of any objections to the Motion.

Based on the foregoing, and for other good cause appearing, the remaining dates
