ORDER APPROVING CUSTOMER SERVICE AGREEMENT

ISSUED: January 23, 2014

On November 5, 2013, Rocky Mountain Power, a division of PacifiCorp (“PacifiCorp”), filed a request for approval (“Request”) of its agreement with Springville City, Utah (“City”) whereby PacifiCorp agrees to allow the City to provide electric service to certain customers (“Additional Customers”) located outside its municipal boundaries and located within PacifiCorp’s certificated service territory (“Agreement”). The Additional Customers are not currently receiving electric service at the requested locations from either PacifiCorp or the City. PacifiCorp indicates the City and PacifiCorp entered into the Agreement, subject to the Commission’s approval, in compliance with Utah Code Ann. §§ 10-8-14 and 54-4-40.

On November 19, 2013, the Division of Public Utilities (“Division”) filed its response to the Commission’s November 7, 2013, Action Request, recommending approval of the Agreement. According to the Division, although the Additional Customers are located approximately ten miles outside the City’s municipal boundaries, the City’s electrical facilities are located within approximately 100 feet of the Additional Customers. By contrast, PacifiCorp’s nearest electrical facilities are located nearly nine miles from the Additional Customers. As such, the Division indicates that it is presently uneconomic for PacifiCorp to provide electric service to the Additional Customers, whereas it is relatively convenient and economic for the City to provide

electric service to the Additional Customers. The Division further indicates that none of PacifiCorp's current customers will be affected by the Agreement.

The Commission has not received any opposition to PacifiCorp's Request.

ORDER

Based on the Division's recommendation, the lack of opposition to the Request, and for other good cause appearing, the Request is approved.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
