Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Petitioner Utah Association of Energy Users (“UAE”), hereby petitions for leave to intervene in this docket.

In support of this petition, Petitioner states as follows:

1. Petitioner is an organization that represents the interests of large Utah electric consumers who are customers of Rocky Mountain Power or whose rates are affected by Rocky Mountain Power’s rate structure, some of whom own on-site generation.
2. The legal rights and interests of Petitioner and its members may be substantially affected by this proceeding.

3. Petitioner has not fully determined the specific positions it will take or the relief it will seek. Petitioner seeks to intervene for purposes of protecting its interests and the interests of its members as they may appear, particularly on issues of relevance to large electric consumers and owners of on-site generation.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
