Dear Rocky Mountain Power and DSM Steering Committee Members,

Below, please find feedback from Utah Clean Energy regarding Rocky Mountain Power's 2012 DSM Annual Report.

I appreciate the effort that Rocky Mountain Power has made to continually improve both the formatting and information presented in the annual DSM report. The new format is good and the information in contained in the appendices is useful.

I have three suggestions for future reports:

- Please provide a list of the geographical distribution of the completed efficiency projects throughout Utah.
- For non-residential programs, please report the average kWh savings per project as well as reporting any uncharacteristically large projects.
- We would like to see additional information about staffing levels for the Company's DSM programs and a discussion about how the current level of staffing may impact energy savings acquisitions.

Participation in the Company's Re-Commissioning program has decreased markedly over the last few years (31 projects in in 2009, 14 in 2010, 4 in 2011, 5 in 2012). What does the Company attribute this reduction to?

Also, one correction: on page 45 the reference to "Table 45" (the list of engineering firms under contract) should say "Table 38."

Thanks for your consideration of these comments.
