RE: Docket 13-035-T09 – Schedule 37 Avoided Cost Purchases from Qualifying Facilities (QF) Corrections

On May 31, 2013, in compliance with Docket No. 08-035-78 and Docket No. 12-035-T10, Rocky Mountain power filed updated Schedule 37 Avoided Costs. On June 19, 2013, the Division of Public Utilities (Division) met with the Company to discuss the filing and proposed to make a modification to the Company's filing. The modification was to change the percentage split between heavy load hours (HLH) and light load hours (LLH) from 57% HLH / 43% LLH to 56% HLH / 44% LLH based on the Division's calculation of the number of hours in each hour class. The Company does not oppose this change.

In addition, as a result of discussions with the Division, the Company believes that a modification should be made to the Appendix 3 Loads and Resources Study (L&R Study), included in the Company's initial filing. The original Appendix 3 spreadsheet contained logic in several years that did not count a gas plant's capacity in months when it was not dispatched to produce energy. The Company believes that that Appendix 3 should be modified to count a gas plant's available capacity regardless of whether it is dispatched. Accordingly, the Company has incorporated this modification in this filing.

The Company has made the above-referenced changes and prepared revised tariff sheets and other appendices. Enclosed for filing are an original and two copies of updated proposed tariff sheets associated with Tariff P.S.C.U No. 49 of PacifiCorp, d.b.a. Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, PacifiCorp states that the proposed tariff sheets do not constitute a violation of state law or Commission rule. PacifiCorp will also provide an electronic version of this filing to psc@utah.gov.
