During the administration of the Home Energy Savings Incentive Program, Rocky Mountain Power found that several notes were incorrectly referenced for the evaporative cooling and air conditioning measures in Table 1 of Schedule 111. The purpose of this filing is to correct Table 1 and ensure that customers are not denied incentives due to mislabeled requirements. To avoid denying incentive applications due to these errors the Company requests the changes be back dated and effective as of May 1, 2013.

The Company respectfully request the following changes to Sheet No. 111.4:

- 1. Update reference from Note 18 to Note 16:
 - a. Duct sealing electric heating
 - b. Duct sealing and duct insulation electric cooling
 - c. Duct sealing and duct insulation electric heating

- 2. Update reference from Note 19 to Note 17:
 - a. Central Air Conditioner Tune-ups
 - b. Heat Pump Tune-ups

The Company respectfully request the following changes to Sheet No. 111.5:

- 3. Update reference from Note 18 to Note 16:
 - a. 95% AFUE gas furnace with ECM
- 4. Remove reference to Note 17 and add reference to Note 16:
 - a. Evaporative Cooler first time install
 - b. Evaporative Cooler replacement
 - c. Evaporative Cooler premium
 - d. Evaporative Cooler whole house ducted
- 5. Update reference from Note 17 to Note 16:
 - a. Central Air Conditioner 15+SEER and 12.5+EER
 - b. Central Air Conditioner Proper Sizing
- 6. Update reference from Note 18 to Note 17:a. Central Air Conditioner Best Practices Installation
- 7. Update references from Note 20 to Note 18:
 a. Central Air Conditioner Best Practices Installation
- 8. Delete Note 16:
 - a. Note 16. Incentive is available only to customers who use a qualified weatherization trade ally for all qualifying measures.
- 9. Delete Note 17:
 - a. Note 17. Work must be completed by a qualified weatherization or participating windows trade ally per program requirements.
- 10. Removal of Note 16 and 17 result in renumbering remaining notes:
 - a. Note 18 shall be renumbered to Note 16
 - b. Note 19 shall be renumbered to Note 17
 - c. Note 20 shall be renumbered to Note 18
- 11. Update Note 16 (former Note 18) with additional language concerning self-installation. Note 16 to read:
 - a. Work must be completed by a qualified or participating HVAC trade ally per program requirements. Self-installs are allowed for evaporative coolers but self-installers are ineligible for the dealer incentive.
