On June 3, 2013, the Commission issued a Scheduling Order and Notice of Technical Conference in this docket which sets forth dates for a technical conference (July 31, 2013), comments (September 9, 2013) and reply comments (October 11, 2013) to address PacifiCorp's 2013 Integrated Resource Plan ("Draft 2013 IRP").

In Docket 12-035-100, the Commission is currently addressing PacifiCorp's application for consideration of proposed changes to the current method for calculating avoided cost pricing for qualifying facilities, among other things. On June 5, 2013, the Commission held a hearing in Docket 12-035-100, at which the Commission announced a target issuance date for the order in that docket by end of August, 2013.

Because the assumptions and actions contained in the Draft 2013 IRP are related to the avoided cost methodologies under consideration in Docket 12-035-100, the Commission believes that good cause exists to cancel the technical conference scheduled for July 31, 2013, in this docket until after the Commission issues its order in Docket 12-035-100.
