Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Petitioner Renewable Energy Coalition, an Oregon-based coalition of renewable energy project owners and developers, hereby petitions for leave to intervene in this docket.

In support of this petition, Petitioner states as follows:

1. Petitioner is an organization that represents renewable energy project owners and developers in the western United States, some of whom have power-sales and other arrangements with PacifiCorp, parent of Rocky Mountain Power. The Coalition's members' interests may be affected substantially by Rocky Mountain Power's rate structure and resource acquisition plans.

2. The legal rights and interests of Petitioner and its members may be substantially affected by this proceeding.

3. Petitioner has not fully determined the specific positions it will take or the relief it will seek. Petitioner seeks to intervene for purposes of protecting its interests and the interests of its members as they may appear, particularly on issues of relevance to large electric consumers.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
