**RE: PacifiCorp's Update to 2013 Integrated Resource Plan – Docket No. 13-2035-01**

Please find enclosed the original and ten (10) copies, along with a CD, of PacifiCorp's 2013 Integrated Resource Plan (2013 IRP) Update. Copies of the 2013 IRP are also available electronically on PacifiCorp's website, at [www.pacificorp.com](http://www.pacificorp.com). Confidential information in the 2013 IRP Update will be provided to state regulators and any party who has signed a non-disclosure agreement in this Docket. PacifiCorp requests that interested parties contact the state manager listed below for a copy of Appendix A that must be executed and submitted prior to obtaining a copy of the confidential information.

The main changes included in the 2013 IRP Update include:

- 1) updated load forecast with a 320 MW average reduction to forecasted system peaks,
- 2) updated the power and natural gas forward price curve to incorporate lower prices,
- 3) updated Energy Gateway in-service dates to coincide with revised permitting dates, generation facility needs and load growth assumptions,
- 4) updated to incorporate recent EPA rulings on the Wyoming Regional Haze state implementation plan (SIP) and federal implementation plan (FIP).

With a reduced coincident system peak forecast and lower market prices, the updated resource portfolio continues to show that customer loads over the front ten years of the planning horizon will be met with front office transactions (firm market purchases) and through energy efficiency. PacifiCorp continues to pursue acceleration of cost-effective energy efficiency consistent with its 2013 IRP Action Plan.
