Re: Docket No. 14-035-102, In the Matter of Rocky Mountain Power's Semi-Annual Demand-Side Management (DSM) Forecast Reports

Dear Public Service Commission,

On July 22, 2014 Rocky Mountain Power ("Company") filed with the Public Service Commission ("Commission") its semi-annual Utah DSM tariff rider balancing account analysis, pursuant to Commission order in Docket No. 09-035-T08. On July 30th, 2014 the Company submitted a revised DSM tariff rider balancing account analysis using an AFUDC rate of 7.77% instead of 7.83% for 2015.

On August 20, 2014 UCE and SWEEP submitted general comments requesting additional information about the MW and MWh savings associated with the time period reflected in the balancing account analysis, and on September 2, 2014 the Company submitted reply comments objecting to our request.

UCE and SWEEP understand that the Utah DSM tariff rider balancing account analysis report is financial in nature as agreed to by parties. However, we are interested to know if budget changes presented in the DSM tariff rider account analysis report are expected to have any impacts on forecasted MW and MWh savings, including but not limited to the timing of when the energy and demand resources will be acquired. We appreciate that the Company makes an effort to review variations in the forecasted and actual energy performance with the DSM Advisory Group and DSM Steering Committee, but sometimes this information is not presented. As an alternative to providing this information in the DSM tariff rider balancing account analysis, we request that the Company add this topic as a fixed agenda item to the DSM Advisory Group and DSM Steering Committee meetings on a semi-annual if not quarterly basis. Providing this information as a regular agenda item at these meetings would satisfy our original request. In addition, inclusion of forecasted MW and MWh savings in the next semi-annual report as proposed by the company would be helpful.
