On August 11, 2014, PacifiCorp, dba Rocky Mountain Power ("PacifiCorp") filed an application ("Application") in this docket requesting approval of a partial requirement master electric service agreement ("Agreement") between PacifiCorp and Tesoro Refining and Marketing Company ("Tesoro"). PacifiCorp explains that the Agreement is consistent with the prices and other terms related to PacifiCorp's Electric Service Schedule 31 – Back-Up, Maintenance, and Supplementary Power ("Schedule 31"). PacifiCorp states the proceeding in which prices and other terms related to Schedule 31, in Docket No. 13-035-196, recently concluded with a final order issued by the Commission on July 23, 2014. See *In the Matter of the Application of Rocky Mountain Power for Approval of Revisions to Back-Up, Maintenance, and Supplementary Power Service Tariff, Electric Service Schedule 31*, Docket No. 13-035-196 (Order Confirming Bench Ruling; July 23, 2014) ("Order").

PacifiCorp indicates the parties had limited time to negotiate the Agreement after the issuance of the Order and before the August 31, 2014, expiration of the existing 2013 agreement between PacifiCorp and Tesoro. As such, PacifiCorp requests expedited review of
