8766 lbs=4.4 tons (\$50/ton fee)(4.4 tons/7200 kWh)= \$.03/kwh fee

Dear PSC.

I am commenting on the proposed changes requested by Rocky Mountain Power to Solar Power reimbursement for residential customers.

I served in the past on Governor Bangeter's Environmental Health Committee, and was Chairman of the Utah Medical Society Environmental Health Committee. I am a licensed Radioactive material user in the state of Utah. I serve on the Big Cottonwood Canyon Community Council, and am on the Board of Directors of the Forest Glen HOA in Big Cottonwood Canyon. I served in the National Health Service Corp for two years in Emery County Utah and practiced Cardiology in Salt Lake County for 30 years at LDS Hospital, IMC and at the University of Utah.

I oppose the proposed change in reimbursement for solar residential requsted by Rocky Mountain Power. The proposed change will create a barrier to new solar electricity residential customers and directly lead to increased air pollution in the Salt Lake Valley as well as an increase in global temperatures. With fewer Solar units, more electricity will need need to be produced by coal or natural gas. With less Solar there will be more stress on the electric grid as more power flows to homes. Power flowing through lines and transformers causes wear and tear on the grid. Residential solar power, if widespread, would reduce stress on the grid and improve longevity of existing infrastructure.

The argument that solar customers do not pay a fair share of grid expense is wrong. By reducing wear and tear on the grid, solar customers support other users with large power needs that cause power line heating and line wear. The PSC should consider environmental issues, as those issues effect economic growth in Utah. The message this rate change would send to companies looking to move to Utah is clear: Utah doesn't consider environmental issues, air pollution and it's consequent health issues.

I would encourage the PSC not to approve the change in solar reimbursement, but instead, to recommend to Rocky Mountain Power a rate structure which would increase the number of residential solar units.

To whom it may concern,

I'm a concerned citizen regarding the proposal by Rocky Mountain Power to restructure their pricing for net-metering solar power customers. I'd like to strongly urge the UPSC to consider alternate adjustments.

My understanding is that Rocky Mountain Power has calculated that solar power net-metering customers are paying a disproportionately low amount towards their use of the standard electric grid due to volumetric differences in use at different times of day. As a consequence of this disparity in payment, costs of maintenance of the grid have been shifted to non-solar households. This effectively acts as a subsidy towards solar net-metering households.

I empathize with concerns expressed by some other community members who feel this unfairly distributes collective money into the hands of individual parties (and most likely only wealthier individuals at that). Typically, subsidies would cover communally shared resources, such as parks, so everyone paying into the system would be able to reap the rewards.

However, speaking from the perspective of a homeowner who is currently unable to invest in solar energy, I would prefer that I pay more if it means others in the market are economically motivated to shift to alternate energy sources. Our state, and beyond that the world, are facing a dire situation due to dependence on fossil fuels that have and continue to damage our environment.

While I believe that the free market could address these concerns, due to the low cost of oil and coal, there is limited economic viability in breaking into the market. And while businesses may be able to develop more cost effective solutions to renewable energy over the coming years, unless there is economic incentive to do so, individuals will be unlikely to transition to these alternate systems, and we need them to do it now more than ever.

While the electric grid is a communal resource that all participants should pay to maintain, our environment is also a shared resource that is protected by the willingness of Utah citizens to install and maintain solar energy technology for their homes. These efforts should be subsidized, even if it does mean putting a burden on others in society.

Finally, my understanding is that the current question on the table is whether Rocky Mountain Power ought to even be permitted to present their case for full discussion. I would like to emphasize that they absolutely should be able to discuss their case — transparency with their costs and figures for all participants in the electric grid, net-metering and non-net-metering alike, will be absolutely necessary to make an educated decision. However, please remember that this is not only an economic decision, but an environmental one as well.

This is "coincidentally" the life span of solar panels. It now appears that we may never break even. What Buffett & Nevada Power did (with help of the Nevada PUC) to destroy home and small solar in Nevada, Buffett and Rocky Mountain Power are now set to do in Utah. You're probably already aware of this announcement by Rocky Mountain Power of "a proposed three-prong rate increase for any new solar customers after Dec. 9"--also "a onetime application fee of \$60 to cover administrative costs and a \$15 fixed monthly rate charge for other costs like customer service and meters." "In addition, the utility company is proposing to charge \$9.02 per kilowatt for peak period demand and 3.81 cents per kilowatt-hour for the amount of energy used — new rate structures that the utility company says more accurately capture costs and benefits associated with rooftop solar customers." Nevada legislature was heavly lobbied by NVPOWER to not increase the caps. So they Nevada legislature did nothing and stated they would leave this up to the PUC. The PUC 3 members are all appointed by the governor and the chairman of the PUC name is David Noble who is also reported to be against solar panels and is only supportive of

geothermal production. "The PUC Not only just rejected the cap increase they also enacted a new rate structure for net metering by slashing over five years the price paid for excess power generated. They also implemented a 15 minute demand fee during peak time. New a grid use rate that increases over 5 years as well. Surprising everyone the 17,000 existing solar residential users weren't even grandfathered as is normal when changes take place. None of these changes PUC enacted were proposed by NVPower. While the 17,000 solar users had entered a agreement with the solar companies they also had to sign contract with NVPower and has been made null and void by the PUC. I have recently read a report in The Salt Lake Tribune about a rate change request for solar household customers. Although the concept is complicated and not entirely comprehensible by the normal electrical user, the reported sought rate change seems excessive and not logical. These comments are concerning that request as reported.

1. The charge that Rocky Mountain Power considers that the net-metering customer (solar owner) receives "a \$400 yearly subsidy" does not seem logical.

Solar owners deliver their generated energy directly to the Rocky Mountain power grid. The solar owner provides the system to do this at the time of installation of their solar system. Rocky Mountain power is in fact buying from *another* provider who just happens to be smaller than other providers – and closer to the end user. Solar owners should not be charged additionally to transmit (transfer really) their solar generated energy to Rocky Mountain's grid/customers.

The solar owner does not need extensive transmission lines with attendant rights-of-way, maintenance, transformers, or any of the other specialized necessary infrastructure required of distance AC electrical transmission.

I doubt that other energy suppliers to Rocky Mountain Power pay for infrastructure costs that Rocky Mountain Power wants to charge solar owners.

When Solar Owners *use* Rocky Mountain power, then they pay rates reflecting the cost of using Rocky Mountain's infrastructure just like everyone else. When they "sell" power to Rocky Mountain Power, they should not pay infrastructure fees. The statement that solar owners receive "a \$400 yearly subsidy" appears not to be true.

- 2. The proposed \$60 application fee for solar users: Currently there is considerable lag in the approval process mostly by local city officials and Rocky Mountain Power. To charge the user with a fee for a lengthy and inefficient process over which we have no control is onerous. The \$60 application fee for solar customers is excessive. We shouldn't be burdened with inflated costs of an inefficient approval system. Treat it like any other construction approval.
- 3. The Rocky Mountain power plan to grandfather the old rate to current solar customers is to be commended. I chose solar power not only because of environmental logic but also for its long term dollar benefit. I have already made the investment although the project is not complete and may not be at the time of your hearing decision. As my investment was made considering current rate regulations then it should qualify for grandfathering. Grandfather into the old rate on terms of purchase commitment not terms of completion.

Why aren't utility customers billed based dif ferent amounts based on their location, or their wastefulness, or the costs incurred by the utility by each customer? Wouldn't this be more fair? Absolutely not. Utilities are *full* of subsidies. We all understand that. Have there been hoards of citizens banging on your door , complaining about the extra few pennies they may or may not be paying on their bill because of solar customers? No. I know you've seen a few outspoken people, but only because Rocky Mountain Power is trying to rile up its customers against net metering using careful PR and skewed surveys.

According to articles reporting on this proposal, "Rocky Mountain Power says they pay homeowners with solar panels about 14 cents per kilowatt hour for any excess power the customers produce." This is blatantly and ridiculously false. Rocky Mountain Power pays *nothing* for the excess electricity. They have not paid me a dime for my excess electricity which reduces load on power plants during the morning and afternoon and into peak usage periods. They give me a *credit* for each kWh that I offload onto the grid. That electricity naturally flows to the nearest need, which would be within my neighborhood, and that customer pays full retail price to Rocky Mountain Power for that electricity.

RMP wants to set the net metering rate at around \$0.04 per kWh for someone with rooftop solar , along with other extremely complicated rate variables, then sell electricity right back to that same person when the sun is down for more than double that rate, as if residents with rooftop solar are wholesale electricity brokers or should be treated at all similarly.

If this goes into effect, it *wili* devastate the solar industry in Utah. Regardless of the profit argument (RMP says income from these changes would go "into a fund that will be going to our other customers" whatever that means), RMP is trying to completely squelch a model that appears inconvenient to their monopoly.

This has nothing to do with "fairness" to other customers. To claim that is nothing short of ludicrous. Every customer has a basic bill of about \$9 to pay for grid maintenance and other internal costs. You can pinpoint any number of subsets of customers and charge them greater rates because their business costs more money for the utility. But utilities don't do this, except in situations like this where they feel threatened.

Getting more to the heart of the matter, RMP's analyses have not and do not consider the full benefits of solar. They don't even consider the full *financial* benefits to *their* bottom line and therefore that of *all* customers. They disregard the overlap of solar production with peak energy demand times. They overemphasize grid maintenance with vagueries about how net metering customers somehow introduce extra costs to grid maintenance. They ignore what is realistic and focus on what appears to them to be convenient, just as they have done with every prior proposal along these lines.

On a somewhat unrelated note, Rocky Mountain Power is looking into sourcing funding for huge developments to EV charging infrastructure and incentives for installation of such infrastructure. Some of this funding may come from federal grants, but it appears that some of these costs will be paid for directly by regular

customers... This sounds an awful lot to me like "unfair" subsidization to benefit a small subset of customers. (See link 1 https://www.rockymountainpower.net/about/nr/nr2016/electric-vehicles. html and link 2 https://www.rockymountainpower.net/env/utah-sustainable-energy-plan. html) Obviously, "fairness is simply a buzzword meant to incite strong emotion and elicit support from the PSC. I hope you don't fall for it and see past to their true motives. Rocky Mountain Power is a corporation and will do everything in its power to protect it's old business model rather than adapt and change to better fit a changing world.

Please consider these comments and those of so many others in opposition to RMP's latest proposal. Nate W

Request (Closed): Dear Governor Herbert, On November 9, Rocky Mountain Power filed a request before the Public Service Commission to adjust the net metering rate schedule for new solar installs. First, I want you to know that I already have a rooftop solar system that would be grandfathered into the existing rate schedule, so I would not be directly affected by the rate changes. I also am not an employee or investor in any company that installs solar. I say this to point out that I don't have a vested financial interest in these proceedings, and instead my outrage is based solely on a desire for honesty and fairness. Second, I also want to say that I agree with the main premise of Rocky Mountain Power's argument - that the current net metering structure will \*eventually\* cause regular customers to subsidize solar net metering customers. But RMP's actions are based completely on improving their own bottom line, rather than trying to be fair or protect their customers. Let's dissect RMP's new rate schedule proposal. The application fee for a new net metering application is completely reasonable. In fact, I was surprised when I didn't have to pay anything to have RMP come out and change my meter, not to mention the paperwork and actual design review that they did. Second, the new \$15 net metering surcharge. While a minor minimum fee could be reasonable to cover flat costs associated with managing account, there is already a \$6 minimum charge on our bills, and \$15 is a spite charge. It does \_not\_ correspond to any actual cost that RMP bears in order to support net metering customers. Basically they're saying that they had a capital cost to build power plants and other infrastructure, in expectation of getting a return on investment of a certain number of years. But now people don't want to buy enough of their services, so they're trying to mandate minimum charges to correct their mistake of mis-predicting future demand. Since when are customers responsible for ensuring that a mismanaged company gets bailed out? Oh yes, when they can convince the government to bail them out! Third, the cost of energy. This is where RMP should be focusing their efforts. When we look at why net metering customers need RMP at all, it's for using the grid as a "battery" - to absorb excess production, and provide in times of shortfall. So let's make the energy rate reflect that - by \_not\_ having a 1.1 exchange of energy being bought vs. being sold. It should instead more closely reflect wholesale energy rates. Which actually means that at times the energy being "sold" back to RMP is above retail, and at other times is far below retail. It just depends on the time of day. Instead RMP is proposing dropping the rate substantially for both directions, in a bid to show good faith, but hide the most

egregious part of their new rate schedule: the demand charge. The demand charge, and RMP's outright lies, are what will really kill solar. Their statistics say that the average peak demand of a household is 1.6kW. Let me help you understand this. A typical \*hair dryer\* uses around 1.5kW. A microwave could use 1.8kW - the limit of the smallest electrical circuit in a house (1.8kW). Basically they're saying \*nobody\* uses air conditioning (3-10 kW depending on size), a stove (3-5kW), an electric dryer (5-8kW), etc. Nevermind anyone with a hot tub (3-6kW), an electric car (6-20kW). Looking at my own energy usage last month, I paid an electric bill of ~\$80. If I did not have solar panels at all, it would have been ~\$140. If I was on RMPs new rate schedule, with solar, my bill would have been \$160!!! I would literally be paying RMP \*extra\* for the privilege of producing a significant fraction of my own energy, and also exporting a good portion of that during daytime, near peak, helping RMP satisfy the load for other customers. This doesn't even count my own expense of paying for the solar panels. In exchange, because I just happen to use some electricity faster in the evenings, RMP gets to gouge me. Tell me this makes sense?!?! aa In conclusion, I hope that you can look into this issue without taking RMP's "experts" at their word, and instead see through to how this actually effects customers. Do not allow the government to essentially bail RMP out. And remember - RMP is building their own solar "power plants". If it's good financial sense for them to do it, how can it be so bad for them to have other customers do it? They really just want to hoard the entire solar pie to themselves.
