SCHEDULING ORDER AND NOTICES OF HEARING AND PUBLIC WITNESS HEARING

ISSUED: November 18, 2016

Pursuant to the Notice of Scheduling Conference the Commission issued on November 9, 2016, the Commission held a scheduling conference in this docket on November 17, 2016 to set a schedule and hearing dates with respect to the adjudication of PacifiCorp dba Rocky Mountain Power's ("PacifiCorp") Compliance Filing and Request to Complete All Analyses Required under the Net Metering Statute for the Evaluation of the Net Metering Program ("Request"). The scheduling conference was well attended with the following participating in person or by telephone: PacifiCorp, the Division of Public Utilities ("Division"), the Office of Consumer Services ("Office"), the parties who have previously been granted intervention in this docket ("Intervenors") and numerous other stakeholders and concerned citizens.

PacifiCorp proposed a schedule with motion practice to commence by December 20, 2016, motions to be fully briefed by January 26, 2017, and direct written testimony to be filed by March 30, 2017 with a hearing date to be set the week of June 5, 2017. The Office proposed an alternative schedule, arguing the motion practice will present threshold issues, and the Office will be able to more efficiently and effectively deploy its resources if the Commission hears and decides potentially dispositive motions further in advance of requiring direct written testimony. The Office concurred with PacifiCorp's proposed schedule for dispositive motions and suggested an alternative schedule thereafter with direct written testimony due by June 8, 2017 and a hearing

to be set the week of August 14, 2017. The Intervenors generally agreed with the Office, reiterated its arguments concerning the efficient use of their limited resources and supported the Office's proposed schedule. The Division represented it could accommodate either proposed schedule and that it was neutral as to which the Commission adopts. All parties stipulated to a December 20, 2016 intervention deadline with respect to participating in the adjudication of PacifiCorp's Request and to turnaround times with respect to data requests as outlined below.

In advocating for its proposed schedule, PacifiCorp emphasized its Request is the latest iteration of a process that it commenced in 2014 and that its proposed schedule gives the parties ample time to prepare for hearing. The Commission recognizes PacifiCorp's interest in bringing this docket to a conclusion. The Commission also recognizes the complexity of PacifiCorp's filling and the Office's and Intervenors' interests in utilizing their resources effectively and efficiently in responding to the Request. The Commission believes the Office's proposed scheduled is a relatively modest extension of the schedule PacifiCorp proposed and that it is reasonable to address potentially dispositive legal issues before requiring the parties to expend significant resources preparing for hearing. Accordingly, the Commission adopts the Office's proposed schedule as detailed below:
