I am writing to comment on your proposal to raise fees on net metering accounts. I am sure the utilities would like to see this happen as it allows them to increase their bottom line. I understand their point concerning their subsidizing hook-up and infrastructure charges by overpricing the actual electricity. I suppose this was a viable mechanism at one time but it seems to have outlived its usefulness. Perhaps it is time to de-link the transmission from the generation and charge the actual cost for each to each customer. I would certainly support a bill that charges for the infrastructure and a separate charge for the amount of electricity used.

If the base price increases much more at some point it will be feasible to install a battery set and go completely off the grid. Back-up generators are not that expensive if we need additional power. I think there are economies of scale so I would not want to become an independent generator but all things become a possibility as the status quo becomes more expensive. Please take note of this desire in your future dealings with the electric utilities.

I put solar on my home this year, not because of the money savings, but because of the environmental factor. It was decision we made because of the the smog that we endure in our city every year. It also had to make economic since, which it did at this time. I spent thousands of dollars putting solar on my home. I expected to pay my fair share for any power I used that exceeded my solar generated power. I knew I would have months that I would run short by small amounts and other months that I would have a surplus. I have only seen the changes the last two months, however what I have seen is that my first bill was \$9.05, which was pretty much the base fee and taxes that Rocky Mountain Power charges.

I understand Rocky Mountain has done research that claims that solar owners are causing non solar customers to pay more. They want to penalize new solar customers by raising the minimum monthly fee, but also charging outrageous fees per kw.

power that goes back into the system that they get to use for other clients. The surplus power that goes back into the system reduces their costs. When I run short on power and use the "grid" it will not be at peak times, it will be when there are shorter days in the winter. During the summer months peak times, I am using my energy from my solar panels, not drawing from Rocky Mountain.

Rocky Mountain Power has an incentive to penalize solar, because it interferes with their profits. They are heavy users of fossil fuels, which ruins our climate and contributes to smog. Solar produces clean energy that does not put pollution back into our climate. This means that we have clean air to breath if we are able to use more solar. Please do not allow Rocky Mountain Power to cheat Utah from being a state that offers the public the ability to have clean energy. Please do not allow Rocky Mountain to continue to have a monopoly in Utah. This email is to strongly protest against Rocky Mountain Power's recent unsubstantiated proposal for a tariff increase for "new" net metering customers. This proposal is a thinly vailed assault on homeowner choice for placing solar panels on our roofs. We were required by a law instigated by RMP, to engage net metering in order to obtain their (RMP's) "inspection and approval" to start generating power with solar panels that we purchased and paid to install on our roof.
