I oppose RMP's proposed Net Metering Program. It takes a giant step backward in the efforts to reduce pollution, to use sustainable resources, and to encourage people to conserve energy. It is short-sighted in looking toward future energy configurations. We installed solar panels a few years ago, knowing we would likely never recoup the outlay costs. Had we not benefited from federal incentives, we probably would not have been able to afford it at all. We were willing to absorb these costs because the long term benefits to our local community and planet are worth it. What we did not anticipate, but we have since found as another major benefit, is that having the panels changed our mind-set about how much power we use. We are much more conscious about reducing our power usage in general than we were before we installed the panels.

It is also hypocritical to me that Rocky Mountain Power encourages customers to invest in their solar programs, but now want to penalize people who are willing to pay for their own solar panel purchase and installation.
