SECOND ORDER AMENDING SCHEDULING ORDER

ISSUED: May 8, 2015

On January 23, 2015, the Public Service Commission of Utah ("Commission") issued a Scheduling Order and Notices of Technical Conference and Hearing ("Scheduling Order") in this docket that was amended on April 27, 2015, to accommodate ongoing settlement negotiations among the parties ("First Order Amending Scheduling Order").

On May 5, 2015, PacifiCorp filed a settlement stipulation ("Stipulation") that requests the Commission to vacate the testimony deadlines for all issues in this docket except the issue related to PacifiCorp's capacity contribution study for wind and solar resources ("Study"). PacifiCorp's counsel also informed the Commission's designated Presiding Officer that she had conferred with the settling parties who request the Commission consider the Stipulation at a separate hearing on May 26, 2015, in advance of the hearing to consider the Study, scheduled for June 18-19, 2015. Counsel for PacifiCorp also indicates the settling parties would like the option, but not the obligation, to provide pre-filed written testimony addressing the Stipulation in advance of the Stipulation hearing.
