On December 22, 2014, the Public Service Commission of Utah (“Commission”) issued a Scheduling Order and Notices of Confidential Technical Conference, Prehearing Conference, Hearing and Public Witness Hearing (“Scheduling Order”). On April 16, 2015, PacifiCorp, dba Rocky Mountain Power (“PacifiCorp”) filed a settlement stipulation in this docket (“Stipulation”). PacifiCorp represents no intervening party opposes the Stipulation. The Stipulation recommends the Commission approve the Stipulation and all of its terms and conditions. The Stipulation further requests the Commission consider the Stipulation at the hearing scheduled in this docket.

Based on the foregoing and for other good cause showing, the Commission modifies the Scheduling Order and will consider the Stipulation at the hearing in this docket, beginning at 3:00 p.m. (MDT) on Tuesday, April 21. In light of the Commission’s consideration of the Stipulation, the second and third days of the hearing previously reserved and noticed for April 22-23, 2015, are unnecessary. The Commission will conduct a Public Witness Hearing to consider the Stipulation on Tuesday, April 21, 2015, beginning at 5:00 p.m. (MDT), as previously noticed.
