FIRST ORDER AMENDING SCHEDULING ORDER

### ISSUED: April 17, 2015

On December 22, 2014, the Public Service Commission of Utah ("Commission") issued a Scheduling Order and Notices of Confidential Technical Conference, Prehearing Conference, Hearing and Public Witness Hearing ("Scheduling Order").
