ORDER APPROVING ELECTRIC SERVICE AGREEMENTS

ISSUED: September 4, 2014

On June 12, 2014, Rocky Mountain Power, dba PacifiCorp (“PacifiCorp”), filed with the Public Service Commission of Utah (“Commission”) a request for approval (“Request”) of agreements between PacifiCorp and the following Utah municipalities: Beaver City; Blanding City; Bountiful City; Brigham City; Eagle Mountain City; Enterprise City; Ephraim City; Helper City<sup>1</sup>; Hurricane City; Hyrum City; Lehi City; Town of Levan; Logan City; Morgan City; Murray City; Nephi City; Parowan City; Price City; and Provo City. Under each agreement, PacifiCorp and the respective municipality agree PacifiCorp will continue providing electric service to certain customers located outside its certificated service territory and within the municipality’s municipal boundaries (“Agreements”).

On July 23, 2014, the Division of Public Utilities (“Division”) filed comments pursuant to the Commission’s June 25, 2014, Notice of Filing and Comment Period. The Division indicates the customers listed in the Agreements have been served by PacifiCorp for a period going back decades. The Division further states it reviewed the Request, the Agreements,

<sup>1</sup> On July 11, 2014, PacifiCorp filed a letter with the Commission indicating its June 12, 2014, Request inadvertently included request for approval of an agreement between PacifiCorp and Helper City, which had previously been submitted by PacifiCorp on February 7, 2014, in Docket No. 14-035-18, and approved by the Commission in its order issued April 15, 2014. PacifiCorp’s letter requests the agreement with Helper City be withdrawn from the Request.

and the responses to data requests from PacifiCorp. Based on its review, the Division believes the Agreements comply with the applicable statute (Utah Code Ann. § 54-3-31) and therefore recommends the Commission approve the Request.

The Commission has not received any opposition to PacifiCorp's Request.

ORDER

Based on the Division's recommendation, the lack of opposition to the Request, and for other good cause appearing, the Request is approved.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to §§ 63G-4-301 and 54-7-15 of the Utah Code, an aggrieved party may request agency review or rehearing of this Order by filing a written request with the Commission within 30 days after the issuance of this Order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission does not grant a request for review or rehearing within 20 days after the filing of the request, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a petition for review with the Utah Supreme Court within 30 days after final agency action. Any petition for review must comply with the requirements of §§ 63G-4-401 and 63G-4-403 of the Utah Code and Utah Rules of Appellate Procedure.
