Schedule 114 – Air Conditioner Direct Load Control Program (A/C-DLC) (Cool Keeper Program)

Rocky Mountain Power (Company) hereby submits for filing an original and five copies of proposed tariff sheets associated with Tariff P.S.C.U. No. 49 applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, Rocky Mountain Power states that the proposed tariff sheets do not constitute a violation of state law or Commission rule. The proposed changes clarify how qualifying equipment can be cycled, correct the web address, and remove barriers to participation for commercial and industrial customers. Barriers that limit participation unnecessarily also limit the potential benefit of the program. The Company's third party vendor currently markets the program to qualifying commercial and industrial customers. Unlike residential, commercial and industrial customers often have separately zoned spaces with unique usage, e.g., administrative space in an industrial facility. Proposed changes to the tariff remove the barrier for these customers to participate. Additionally, because air conditioning units up to 15 tons utilize the same installation procedures and equipment as the smaller units, increasing commercial air conditioning unit sizing from 7.5 tons to 15 tons removes a barrier to participation without creating additional costs to the program.

The Company presented the proposed changes on February 12, 2014 to the Utah Demand Side Management Steering Committee. The attached changes reflect the discussion and the input received from the Steering Committee. The Company is not aware of any opposition to the proposed changes.
