### **DEFINITIONS** (continued)

#### **Solar Facility**

A facility which produces electric energy using the sun as the primary energy source. A Solar Facility may be configured to maximize energy output flat mounted (Fixed Solar), or configured with a device to orient the solar panels toward the sun to maximize output during peak load periods, either with a) fixed solar panels that are peak-oriented via alignment primarily towards the West, or b) with a tracking device (Tracking Solar).

### Wind Facility

A facility which produces electric energy using wind as the primary energy source.

### Winter Season

The months of October through May.

### **Summer Season**

The months of June through September.

#### **Peak Hours**

On-peak hours are defined as 6:00 a.m. to 10:00 p.m. Monday through Saturday, excluding holidays.

Holidays include only New Year's Day, President's Day, Memorial Day, Independence Day, Pioneer Day, Labor Day, Thanksgiving Day and Christmas Day. When a holiday falls on a Sunday, the Monday following the holiday will be the holiday and will be Off-peak.

### **Off-Peak Hours**

All hours other than On-peak.

Due to the expansions of Daylight Saving Time (DST) as adopted under Section 110 of the U.S. Energy Policy Act of 2005 the time periods shown above will begin and end one hour later for the period between the second Sunday in March and the first Sunday in April, and for the period between the last Sunday in October and the first Sunday in November.

**MONTHLY PAYMENTS**: <u>The Qualifying Facility will be paid winter and summer energy</u> prices for Peak and Off-Peak hours. Winter and summer energy payments for Peak and Off-Peak

hours are provided separately for a base load facility, Solar Facility and a Wind Facility. The Qualifying Facility shall have the option of either: a) taking the applicable capacity and average energy price payment, or b) taking the applicable winter and summer energy payment for Peak and Off-Peak hours. Once an option is selected the option will remain in effect for the duration of the Facility's contract. Capacity kW will be the maximum 15-minute generation during Peak Hours. A Wind Facility, taking the capacity and average energy

price option, will be paid a reduced capacity payment equal to 20% of the Capacity Price multiplied by the Capacity kW.
