- 11. Company and/or Program Administrator will employ a variety of quality assurance techniques during the delivery of the program. They may differ by equipment or service type and may include, but are not limited to, pre and post installation site inspections, phone surveys, retailer invoice reconciliations, <u>and</u> confirmation of customer and equipment eligibility, and confirmation of incentives received through other utility programs.
- 12. Company may verify or evaluate the energy savings of installed equipment or services. Verification or evaluation may include, but are not limited to, telephone survey, site visit, billing analysis, <u>and pre-</u> and post-installation of monitoring equipment as necessary to quantify actual energy savings.
