Re: Notice of Complaint-Rocky Mtn Power 14-035-T08, Proposed Revisions to Electric Service Schedule No 111, Home Energy Savings Incentive Program

Dear Utah Public Service Commission,

This firm represents Codale Electric Supply, Inc. ("Codale"), a Utah corporation. Among other things, Codale is an electrical distributor including for LED down lights. Codale is headquartered in Salt Lake City, Utah, and has served Utah residents and companies since 1975.

Codale has been recently alerted that the Utah Public Service Commission ("UPSC") has proposed, or is entertaining, changes to the current rebate incentive system that will change the rebate program to a "Up Stream" model that would effectively only allow retailers, and not electrical distributors like Codale, to participate in the rebate program. Codale is in the process of reaching out to the UPSC and looking into whether and what the specifics are in connection with any suggested changes to the rebate program, and reserves the right to supplement this notice. However, in the meantime, please be advised of the following:

Codale hereby notifies the UPSC that it objects to and complains of any changes in the rebate program that would allow for retailers to take advantage of the rebate incentive program, while electrical distributors are not afforded the same opportunity.

Such conduct would improperly discriminate against companies like Codale, and other similarly situated electrical distributors, and provide a clear and unfair pricing and otherwise competitive advantage to retail companies like Lowes or Home Depot. Such conduct may give rise to claims for unfair competition and other anti-competitive practices prohibited by Utah law. If any policy or program is implemented that allows for certain retailers to take advantage of a rebate program to the detriment of electrical distributors, Codale will pursue whatever lawful measures it has available to remedy the

situation. Therefore, we ask that the UPSC reject any changes or proposals that would effectively and unfairly benefit retailers to the detriment of electrical distributors like Codale.
