DISCOVERY

Interested parties planning to attend the confidential technical conference must: (1) have been granted intervention by the Commission and executed a non-disclosure agreement; or (2) or otherwise be entitled to review confidential and or highly confidential information under Utah Admin. Code. § R746-100-16A.1.d. We request PacifiCorp to lead the discussion.
