



Paul / Bruce,

I'only have a couple technical changes and one business request. There are listed below:

- 1. In the definitions section on "Expected Energy" I have change the 0.5 Mwh reduction to 2803 Mwh. This is the same change we had to make in the amendment for Utah Red Hills and should just be a clean up issue.
- 2. The Business request. In section 8.2.2 I am requesting that the Default Security Ratchets up in year 13 as opposed to year 10. This is related to the amount of levelized security In Exhibit 8.3.2 that the project will have in year 10 is around \$19mm and close to the highest level. I think the ratchet up should be once the levelized amounts come down to a balanced amount.
- 3. In Exhibit 6.1 A I have added "Approximately" as the DC size always move around slightly.
 - 1. Under B again I added "approximately" and corrected the delivery rate to "80 Mw instantaneously"
 - 2. We increased the auxiliary energy requirements up to "100,000Kwh/yr"

Aside from these minor tweaks I am good with the changes that Bruce sent over. If we can get this finalized today I can sign.


