Re: Reply Comments

In the Matter of Rocky Mountain Power's Application for Approval of a Pole Attachment Agreement with Rocky Mountain Power and TDS Baja

Broadband, LLC - Docket No. 15-035-82

On November 17, 2015, the Public Service Commission of Utah ("Commission") issued a Notice of Filing and Comment period in the above referenced matter, allowing parties to file comments by December 14, 2015, and reply comments by December 29, 2015. The Division of Public Utilities ("DPU") filed comments on December 8, 2015. Rocky Mountain Power ("Company") provides these reply comments in response to the DPU's comments.

The Company agrees with the DPU that the Company's current Joint Use Distribution Construction Standards are in conformance with Utah Admin. Code § R746-310-1 (B)(13) which requires adherence to the 2007 version of the National Electric Safety Code. The Company also suggests that the definition of "National Electric Safety Code" in Utah Admin. Code R746-310-1 (B)(13) could be changed to define the most current version of the NESC, rather than the 2007 version. The Company is also in agreement that the National Electric Safety Code is updated every five years and the current version of the National Electric Safety Code is dated 2012. The Company notes that while the National Electric Safety Code is updated every five years, oftentimes there are very few substantive changes made.

To reply to the DPU's inquiry regarding the Company's procedures for updating its construction standards, the Company states that beginning in 2014, the Company implemented a documentation process in order to formerly document its reviews of its Construction Standards (Standards). Prior to this, individual users performed reviews in order to ensure that the most recent NESC standards were being used, but the review date was not formerly documented. If the new version of the National Electric Safety Code requires changes to the Standards, it is issued a new "published and reviewed date". If the National Electric Safety Code does not require changes to the Standards the document will be issued a new review date and no change will be made to the published date. Instances wherein the last review date shown in the footer of the Standards is earlier than 2012 are likely minor oversight by the user in failing to update the review date in the footer of the Standards.

The Company has completed a subsequent review of the Standards and identified three items that need to be modified. In EU 101, section 6 and EU 401, section 9 a reference is made to NESC Rule 279A3. This is a typo. The correct reference is NESC 279B3. The Standard itself is current. In EU 281, the clearance shown in Figure 1 requires 24 inches from supply service to communication cross-arm and was in conformance with the 2007 version of the National Electric Safety Code. EU 281 will be updated to require 30 inches from supply service to communication cross-arm in conformance with the 2012 version of the National Electric Safety Code.
