Resolute puts forth two Chapter Resolutions which Resolute claims show "serious dissent and concern among the people who would be affected if the Commission grants the Application."² Additionally Resolute suggests "given the distance, difficulty, and cost of travel, it would be much simpler for the Commission to travel"³ to hold a Public Witness Day in the area affected by the Rocky Mountain Power's application.

The Division supports Resolute's Request. Holding a Public Witness Hearing on or near the affected area would be in the public interest because it should facilitate public participation and assist the Commission in having a full and fair record upon which to make its decision. While it is not common to do so, in the past the Commission has held Public Witness Hearings outside of Salt Lake County. For example, the Commission has held Public Witness Hearings in Beaver⁴ and Vernal, Utah.⁵ The Division believes that it is appropriate for the Commission to hold a Public Witness Hearing near the affected area in this case.
