RE: Notice of Intent to File Sustainable Transportation and Energy Plan (“STEP”) Act
Initiatives
Docket No. 16-035-__

On March 29, 2016, pursuant to Senate Bill 115, the STEP Act was signed into law. Utah Code Annotated §54-20-103 authorizes a large-scale electric utility to seek approval from the Public Service Commission of Utah (“Commission”) to establish a program that promotes customer choice in electric vehicle (“EV”) charging equipment and service. U.C.A. §54-20-103(3) requires that before the utility seeks approval from the Commission, it must seek input from: (a) the Division of Public Utilities (“DPU”); (b) the Office of Consumer Services (“OCS”); (c) the Division of Air Quality (“DAQ”); and (d) any person that files a request for notice with the commission.

The purpose of this letter is to notify the Commission and interested parties that Rocky Mountain Power (the “Company”) intends to submit a filing for approval of various STEP initiatives in early September 2016. The Company intends to include the EV incentive program as part of that filing.

In accordance with §§54-20-103(3)(a), (b), and (c), the Company met with the DPU, OCS, DAQ, and several other parties May 10, 2016 to seek input for an EV incentive program. To comply with §54-20-103(3)(d), the Company respectfully requests that the Commission issue a public notice by August 19, 2016, if possible, to allow any additional persons not previously involved to file a request for notice with the Commission of their desire to provide input on the Company’s proposed EV incentive program. This will allow the Company to seek input from those persons prior to submitting the EV incentive program for approval.

An original and nine (9) copies of this request will be hand delivered to the Commission. Electronic versions of this filing will also be provided to psc@utah.gov.
