The Utah Sustainable Transportation and Energy Plan Act ("STEP"), codified at U.C.A. § 54-20-103, et. seq. became effective May 10, 2016. Among other things, Section 103 of STEP authorizes a large-scale electric utility to seek approval from the Public Service Commission of Utah ("Commission") to establish a program that promotes customer choice in electric vehicle ("EV") charging equipment and service. Utah Code § 54-20-103(3) requires that before the utility seeks approval from the Commission to establish an EV incentive program, it must seek input from: (a) the Division of Public Utilities ("DPU"); (b) the Office of Consumer Services ("OCS"); (c) the Division of Air Quality ("DAQ"); and (d) any person that files a request for notice with the Commission.

On August 18, 2016, PacifiCorp, dba Rocky Mountain Power (PacifiCorp), filed notice to the Commission and interested parties that PacifiCorp intends to submit a filing for approval of various STEP initiatives (including an EV incentive program) in early September 2016.

PacifiCorp represents that it met with the DPU, OCS, DAQ, and several other parties on May 10, 2016 to seek input for an EV incentive program. PacifiCorp's notice requests the Commission to issue a notice to comply with U.C.A. § 54-20-103(3)(d), "allow[ing] any additional persons not previously involved to file a request for notice with the Commission of their desire to provide input on [PacifiCorp's] proposed EV incentive program. This will allow [PacifiCorp] to seek input from those persons prior to submitting the EV incentive program for approval."
