## SCHEDULING ORDER AND NOTICE OF HEARING

## ISSUED: December 2, 2016

On September 27, 2016, Blyncsy, Inc. (Blyncsy) filed a formal complaint against Rocky Mountain Power, a public utility. On October 27, 2016, Rocky Mountain Power answered the complaint and filed a motion to dismiss it.

On November 10, 2016, the parties agreed to stay further proceedings in order to allow Blyncsy to hire counsel. On November 21, 2016, Gary A. Dodge and Phillip J. Russell entered their appearance as counsel for Blyncsy.

On December 1, 2016, the parties, including the Utah Division of Public Utilities

(Division), convened for a scheduling conference. Pursuant to an agreement of the parties, this matter shall proceed as follows:

- Rocky Mountain Power's pending motion to dismiss shall be treated as a motion for summary judgment.
- Blyncsy shall respond to the motion for summary judgment by Friday, February 3, 2017. Blyncsy's response may be accompanied by testimony.
- If the Division chooses to file an initial brief in this matter, it shall do so by Friday, February 3, 2017.

- 4. By **Friday, February 24, 2017**, Rocky Mountain Power shall file a reply to Blyncsy's response to the motion for summary judgment. Rocky Mountain Power's reply may be accompanied by testimony.
- 5. Any request for intervention shall be filed by Friday, February 24, 2017.
- 6. The parties shall file any final briefing by Friday, March 10, 2017.
- 7. The parties shall conclude discovery by **Friday**, March 10, 2017.
- 8. The parties shall file witness and exhibit lists by Monday, March 20, 2017.

Unless this matter is settled or resolved on summary judgment, the hearing shall take place on **Wednesday, April 5, 2017**, beginning at 9:00 A.M. in the Fourth Floor Hearing Room 451, Heber M. Wells Bldg., 160 East 300 South, Salt Lake City, Utah.
