## **NOTICE OF FILING**

On November 23, 2016, Blue Mountain Power Partners, LLC (Blue Mountain) filed a formal complaint against PacifiCorp d/b/a Rocky Mountain Power (Rocky Mountain Power), a public utility. Blue Mountain alleges that Rocky Mountain Power has breached a Power Purchase Agreement (PPA) executed between the parties and approved by the Public Service Commission of Utah (PSC). Specifically, Blue Mountain alleges that Rocky Mountain Power refuses to recognize that certain performance deadlines set forth in the PPA are subject to extension due to an event of force majeure. Therefore, Blue Mountain requests that the PSC require Rocky Mountain Power to extend the deadlines and perform according to the resulting PPA; or, alternatively, to buy out the PPA for \$25 million.

## NOTICE OF COMMENT PERIOD

Rocky Mountain Power may submit a response to Blue Mountain's complaint no later than **Thursday**, **December 29**, **2016**. Blue Mountain may file a reply no later than **Friday**, **January 13**, **2017**.
