The Utah Association of Energy Users (“UAE”) files these comments in response to the Schedule 94 tariff revisions proposed by Rocky Mountain Power (“RMP”) in this docket. UAE has two primary objections to RMP’s proposed tariff sheets:

(1) References to the “pilot” nature of the EBA were improperly deleted from the proposed tariff sheets. The EBA was adopted as, and remains, a pilot program and the tariff should continue to reflect that fact. The pilot may have been extended by legislative mandate through 2019, but it will remain a pilot program until the Commission has completed its review of the EBA as contemplated in the initial Commission Order. The EBA is and remains a pilot program and should be referenced as such.

(2) The limited duration of the 100% sharing mechanism mandated by SB 115 should specifically be noted in the tariff. The 100% sharing mandate runs from June 1, 2016 to December 31, 2019. The tariff should specifically reflect this limited time frame.
