In response to comments of the Division of Public Utilities (the "Division") in the above referenced matter on June 28, 2016, PacifiCorp, d.b.a. Rocky Mountain Power (the "Company), provides for filing are an original and five (5) copies of proposed tariff sheet associated with Tariff P.S.C.U No. 50 applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405-2(D), the Company states that the proposed tariff sheet does not constitute a violation of state law or Commission rule. The Company will also provide an electronic version of this filing to psc@utah.gov. The Company respectfully requests an effective date of July 31, 2016 for these changes.

Second Revision of Sheet No. 8.1 Schedule 8 Large General Service – 1,000 kW and Over – Distribution Voltage

In its comments dated June 28, 2016 the Division recommended the following clarification to Schedule 8 "...18 consecutive months <u>whereupon the company's billing</u> <u>system will automatically transfer the customer to schedule 6 or another appropriate</u> <u>schedule.</u>" The Company does not object to the intent of the Division proposed clarification; however, the Company suggests removing the prescriptive reference to the operation of the company's billing system. Alternatively the Company suggests the following clarification to Schedule 8 "...18 consecutive months <u>whereupon the Customer</u> <u>will be transferred to Schedule 6 or another appropriate schedule.</u>" The Company proposal provides for the potential circumstance wherein the customer transfer to another schedule may not occur automatically by the company billing system. The proposed changes in rates or provisions of service. After consultation with the Division, the Company asserts that the Division has no objection to the clarification as proposed by the Company.
