Re: *Rocky Mountain Power's Proposed Revisions to Electric Service Schedule No. 140, Non-Residential Energy Efficiency Program*; Advice No. 16-10, Docket No. 16-035-T11

Dear Mr. Lively,

The Commission reviewed the August 5, 2016 filing by PacifiCorp, doing business as Rocky Mountain Power (PacifiCorp), proposing changes to its Non-Residential Energy Efficiency Program (Program) administered through Electric Service Schedule No. 140. PacifiCorp's filing revises Sheet No. 140.25 to add a Small Business Direct Install (SBDI) offering to the Program. The filing also includes Exhibit B – SBDI Frequently Asked Questions to be posted on the SBDI website, Exhibit C – SBDI Cost-Effectiveness Analysis, and Exhibit D – Wattsmart Business Portfolio Cost-Effectiveness Analysis. The Commission also reviewed the August 18, 2016 comments of the Division of Public Utilities (Division) and the August 19, 2016 comments of the Office of Consumer Services (Office) and Utah Clean Energy/Southwest Energy Efficiency Project (UCE/SWEEP).

The Division concludes the proposed changes to the Program are cost-effective and consistent with the Commission's goals to promote cost-effective DSM programs. Therefore, the Division recommends the Commission approve the proposed modifications to Schedule 140. The Office supports offering incentives for small businesses but recommends, among other things, the Commission reject the tariff revisions as filed and require PacifiCorp to refile the tariff clearly identifying the location of detailed Program information, including the timeframe, and how Program changes are noticed. UCE/SWEEP support the changes to the Program and recommend PacifiCorp provide periodic updates to the DSM Steering Committee on the Program performance and participation levels.

In response to the Office's comments, on August 26, 2016, PacifiCorp filed reply comments, including updated Sheet Nos. 140.3 and 140.25, a revised Exhibit B – SBDI Webpage Content, and commitments pertaining to future tariff filings and communication of DSM program changes. According to PacifiCorp, it discussed its reply comments and updated information with both the Division and the

Office. PacifiCorp represents, with the updated information, the Office's concerns have been adequately addressed and it is now supportive of the proposed changes, with an effective date of September 5, 2016.

Based on the Commission's review of PacifiCorp's filings and the parties' recommendations, the First Revision of Sheet No. 140.3, the Third Revision of Sheet No. 140.25, and the revised Exhibit B filed on August 26, 2016 are approved, effective September 5, 2016.
