In the Matter of the Revisions to Dixie Power's Retail Electric Rates

#### RECOMMENDATION

The Utah Division of Public Utilities (Division) recommends that the Utah Public Service Commission (Commission) acknowledge Dixie Escalante Rural Electric Association, Inc.'s (Dixie) changes to its Retail Electric Rates, and make them available for public inspection.

### **BACKGROUND**

The Dixie board approved these changes and presented them at meetings of members held on November 3, 2015, at Desert Hills High School in St. George and on November 4, 2015, at the Elementary School in Beryl, Utah. Dixie's board made the change effective February 1, 2016. Dixie filed notification of these changes with the Commission on February 1, 2016. On February 5, 2016 the Commission issued an Action Request to the Division to investigate the notification. This is the Division's response to that Action Request.



#### **ISSUE**

Dixie's customers were given ample notification of the proposed rate changes as specified in Utah Code 54-3-3 and 54-4-1.1. However, the Commission was not notified at least 30 days prior to the proposed effective rate change as required by Commission Rule (R 746-405-2-E.2) and Utah Code 54-3-3. The Division believes that Dixie should comply with Commission rule and Utah Code by notifying the Commission at least 30 days prior to implementing any such rate change.

#### **DISCUSSION**

On February 1, 2016 Dixie filed with the Commission its revised retail electric rate schedules. In Dixie's attached letter to the Commission it states that these increased rates reflect a \$5 increase in the Customer Charge and an annual wholesale power cost adjustor of \$.0045 per kWh, (which Dixie implemented previously) together these rates represent an average increase of 11%. Also the term "Customer Charge" has been replaced with the term "Facilities Service Charge" to "better represent the costs associated with the fixed base charge assignment."

Dixie previously determined to keep retail rates simple by not implementing rate changes unless the year-over-year rate difference is at least \$.0005 per kWh and that any rate adjustment would be rounded to that number. In 2014 the average wholesale power cost was \$.03408 whereas for 2015 the cost was \$.03865 per kWh, which results in a year over year increase of \$.00457 per kWh. This is greater than the threshold mentioned above. Therefore, the increases in Dixie's rates per kWh are as follows:

#### **CONCLUSION**

The Division recommends that although the Commission was not notified as it should have been, Dixie's customers were given ample notification. Therefore, the Division's recommendation is for the Commission to acknowledge the revised tariff sheets with an effective date of February 1, 2016 and make them available for public inspection while reminding Dixie of its obligation to notify the Commission at least 30 days prior to implementing new rates.
