Yesterday during Moon Lake Electric Association's meeting of the Board of Directors, several modifications were reviewed and implemented that affect the current line extension and service request policies. The policy changes that were approved are made effective today May 11, 2017.

Summary of changes approved.

- Effective immediately there will be a non-refundable staking fee charged for all new service requests, including service upgrades. The cost for small general services will be \$50.00 and for large services, the cost will be \$150.00. These fees will be due and paid prior to performing any staking functions for services.
- 2. All construction Jobs estimated up to \$5,000.00 will be considered firm costs and will not be eligible for refund, unless the job is not built as staked. All estimates above \$5,000.00 will be eligible for refund if actual costs are less than estimate. MLEA personnel will evaluate all of these conditions and determine if an appropriate refund is due to the customer. Eligible refunds are subject to individual line extension agreement terms and conditions.
- Effective immediately, MLEA will no longer offer pro-rate payments for new construction after May 10, 2017. If there is an existing agreement in place that is signed by the consumer, received by MLEA and includes full payment of the job, then the pro-rate will be honored for the 5-year period.
- 4. Any service upgrades that are requested will now have a fixed credit amount for transformers that are to be changed out. Overhead transformers will receive a \$500.00 credit and pad mount 1 phase transformers will receive \$1000.00 credit. 3 phase units will be determined on a case-by-case basis.
- 5. MLEA will no longer offer construction financing for line extensions.
- 6. MLEA will no longer offer service upgrade waiver to the next size of service. All upgrades shall be paid by the consumer.
