On February 22, 2018, the Public Service Commission ("PSC") issued a Notice of Filing and Comment Period in this docket, informing parties they could file comments with respect to PacifiCorp dba Rocky Mountain Power's ("PacifiCorp") Semi-Annual Hedging Report on or before Friday, March 23, 2018 and reply comments on or before Friday, April 6, 2018.

On March 20, 2018, the Division of Public Utilities ("DPU") filed a request to extend the comment period until April 6, 2018. The PSC notes PacifiCorp filed a corrected version of its report on March 8, 2018. Good cause appearing, the DPU's request is granted.
