NOTICE OF INTERIM RATES HEARING

The PSC will conduct an interim rates hearing on **Thursday, May 17, 2018, beginning at 10:00 a.m. (MDT)**. The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah**. All parties must have their witnesses in attendance and prepared to testify.
