#### Dear Commissioners:

Rocky Mountain Power (the "Company") hereby notifies the Public Service Commission of Utah ("Commission") that it has entered into an agreement and subsequent amendment with Castle Solar, LLC to purchase 20 megawatts of renewable energy output from the Castle solar facility on behalf of the University of Utah. In Docket No. 18-035-08, the Commission approved a Schedule 32 contract between the Company and the University of Utah ("University") on May 22, 2018 ("Schedule 32 Contract"). Consistent with Schedule 32, section 4.2 of the Schedule 32 Contract provides that, at the University's request, the Company may enter into Renewable Resource Contracts for additional Customer Renewable Resources to serve the University's load. On September 22, 2020, the Company entered into such a Renewable Resource Contract with Castle Solar LLC, which was amended on July 29, 2021. Schedule 32 does not require approval of Renewable Resource Contracts. However, the Company submits this courtesy notification to the Commission for informational purposes.
