It has come to my attention that the Utah Public Service Commission (PSC) is currently considering comments in the matter of Docket # 18-035-28 concerning the value of expired net-metering credits.

I generally support Utah Clean Energy?s proposals! Specifically, that the PSC consider:

The value of expired net metering credits are NOT being used as effectively as they could be to provide additional assistance to low income families. As I understand it, the company is doing an end-run around legislative intent. Instead of using the money to provide help to low-income Utahns, they are using it to fatten their bottomline.

I understand that we are dealing with a regulated utility and that "fattening the bottom-line" can't happen since the company's over-all rate-of-return is regulated. But that's only if they are earning their target rate.

Their trick of accounting clearly flies in the face of the legislatures desire to help low-income families.

I support the recommendation to transfer these funds to the Weatherization Assistance Program. Doing so ensures that the funds provide additional support for low-income programs rather than offsetting cost.

I wish that Rocky Mountain Power would roll over extra power accrued to the next year, but failing that I like the idea of using that money (>\$150K per year) to help out less fortunate. It seems that current practice is not a very efficient use of this money, despite having the best intentions. Why not use this money to help more low-income homes become energy efficient, which will reduce energy costs not just for one month, but for years to come? Another consideration is a solar pilot program for low-income homes.
