Pursuant to Utah Admin. Code r.746-1, the Division of Public Utilities (“Division”) files this Motion to Amend Schedule. The Division requests that the Public Service Commission (“Commission”) amend the December 16, 2019 Scheduling Order as amended by the Commission’s February 24, 2020 Scheduling Order issued in this docket.

In its February 24, 2020 Scheduling Order the Commission issued the following schedule as stipulated to by the parties:
