On May 29, 2019, PacifiCorp filed a compliance filing pursuant to the Public Service Commission of Utah's ("PSC") Order issued on January 11, 2019 in this docket ("Compliance Filing"). In the Compliance Filing, PacifiCorp proposes to credit \$1,352 to the balancing account for Electric Service Schedule No. 91 – Surcharge to Fund Low Income Residential Lifeline Program. \$1,352 is the difference between the refund amount referenced in the PSC's January Order (*i.e.*, \$159,840) and the actual refund amount to Electric Service Schedule No. 3 Low Income Lifeline Program customers (*i.e.*, \$158,488). Any interested party may submit comments on the Compliance Filing on or before **Friday, June 28, 2019**.
