**RE: Docket No. 18-035-T02 Rocky Mountain Power's Proposed Tariff Revisions to Electric Service Schedule No. 37, Avoided Cost Purchases from Qualifying Facilities**

Rocky Mountain Power (the "Company") filed Advice Filing 18-02, requesting tariff changes to Schedule 37 – Avoided Cost Purchases from Qualifying Facilities, on May 31, 2018. The Company's filing requested an effective date of June 8, 2018 for the tariff changes. On May 31, 2018, the Public Service Commission requested expedited comments from interested parties as to whether the proposed effective date allowed for adequate review time. The Company typically provides a minimum of 30 days for review time for its filings related to tariff revisions to Electric Service Schedule No. 37, and requested the June 8, 2018 effective date in error. The Company will file a revised filing with the correct requested effective date of July 1, 2018 on June 5, 2018. The Company apologizes for any inconvenience this error may have had on parties.
