#### RECOMMENDATION

The Utah Division of Public Utilities (Division) recommends that the Utah Public Service Commission (Commission) accept Flowell Electric Association, Inc.'s (Flowell) updated Index of Electric Service Regulations, and make them available for public inspection.

#### **BACKGROUND**

On April 24, 2019 Flowell submitted its updated Index of Electric Service Regulations believing that, although it had "been operating under these rules for many years" it had "not formally filed them with the Commission."

The Flowell board recently updated these service regulations and is filing a copy with the Commission for reference. The Commission issued an Action Request to the Division on



May 9, 2019

April 25, 2019 to investigate Flowell's filing and make recommendations. This is the

Division's response to that Action Request.

**ISSUE** 

Flowell Electric Association is a non-profit, cooperative organized in 1943 with a service

territory serving eastern Millard County. Flowell infrequently files with the Commission.

There was no cover letter filed with the Index of Electric Service Regulations, the Division

was unsure what relief or requirements Flowell was attempting to fulfill. After reaching

out to Mr. Robison of Flowell we have been provided clarification. Mr. Robison states that

Flowell has had customers misunderstand their policies "because we haven't updated the

service regulations that were probably filed in the 1960's. This filing is our attempt to clear

up any questions and get our service regulations up to date."

**DISCUSSION** 

In this filing Flowell, is not making a request to the Commission. Rather it is sending this

document in an effort to keep the regulators records up to date and to mitigate the

possibilities for further customer confusion. From discussions with Flowell

representatives, the Division understands that Flowell has operated under these service

regulations, which were approved by Flowell's board, for many years. Flowell's

application does not change any rate but rather makes current the filed service regulations

with current practice.

**CONCLUSION** 

The Division recommends that the Commission accept Flowell's Index of Electric Service

and make them available for public inspection.
