ISSUED: April 16, 2020

On April 15, 2020, Utah Clean Energy (UCE) filed an Unopposed Motion to Amend Schedule and Request for Expedited Review ("Motion"), requesting the Public Service Commission of Utah (PSC) amend the Amended Scheduling Order, Notice of Technical Conference, and Notice of Hearing ("Scheduling Order") issued on March 26, 2020. The Motion only proposes to change the deadline, from April 16, 2020 to May 1, 2020, for parties to submit questions to Rocky Mountain Power (RMP) in anticipation of the technical conference, and the date of the technical conference, from April 24, 2020 to May 8, 2020.

UCE states that, consistent with the Scheduling Order, RMP filed its supplemental filing and testimony on April 9, 2020 ("Supplemental Filing") and this filing contains a significant amount analysis, including Integrated Resource Plan modelling, in support of several routine updates and one non-routine update. The non-applicant parties request additional time to review the information in the Supplemental Filing to formulate and submit substantive questions to RMP for the upcoming technical conference.

The Motion represents that UCE contacted all of the parties to the docket, namely RMP, the Division of Public Utilities (DPU), the Office of Consumer Services (OCS), and Salt Lake City Corporation and they support the Motion.
